

**RELEASE AND WAIVER OF LIABILITY
AND INDEMNIFICATION AGREEMENT**

I/We, the parents and/or legal guardians of _____ (the "Youth"), (Birthdate: m / d / y) acknowledge that the Youth is or will be enrolled in one or more sewing and fashion design classes, seminars, open studio time, or activities (the "Classes") offered by, through or on the premises or facilities used by Sew Fun! LLC, a California limited liability company doing business as sewnow! (the "Company") and that the Youth has been admitted to said Classes based in material part on this Release and Waiver of Liability and Indemnification Agreement (this "Release") and my/our consent hereto.

I/We am/are aware of or have been informed of the nature of the Classes and recognize and understand that the activities in which the Youth may participate in connection with such Classes carry a risk of injury, including, without limitation, permanent disability or death, and severe social and economic loss due not only to the actions, inaction or negligence of the Youth, but also the action, inaction or negligence of others, or the conditions of the premises, facility, or of any equipment used. I/We further acknowledge and fully understand that there may be other risks not known to me/us or not reasonably foreseeable at this time. By my/our signature(s) hereto, I/We hereby assume all risks involved in the activities to be performed during the Classes and/or in connection with and accept personal responsibility for any damages following such injury, permanent disability or death.

I/We understand that I/we am/are responsible for evaluating the ability of the Youth to participate in the Classes. I/We will instruct the Youth that, prior to participation in any of the Classes, the Youth is to inspect the equipment and facilities to be used, ensure they do not use equipment on which they have not been fully trained by the instructor or supervisor, and if the Youth believes anything is unsafe or beyond the Youth's capability, the Youth will immediately advise the instructor or supervisor of such condition(s) **AND REFUSE TO PARTICIPATE**; or if the Youth elects to participate notwithstanding the Youth's belief hereunder, the Youth's participation is at the Youth's own risk.

In case of injury or illness, I/we hereby give my/our consent to have a doctor, nurse, other medical emergency personnel, or personnel of the Company provide the Youth with medical assistance or treatment. I/We hereby give my/our consent to emergency transportation and the administration by medical emergency personnel or by personnel of the Company of any first aid and/or medical treatment to the Youth. I/We acknowledge that the Company has not purchased and will not provide any medical, health or accident insurance to cover such expenses and that any such insurance is my/our responsibility. I/We accept responsibility for payment of any such emergency transportation and treatment expenses by any related or subsequent medical bills.

For myself/ourselves, my/our heirs, successors or assigns and legal representatives, I/we hereby waive, release, absolve, indemnify, forever discharge and agree to hold harmless the Company, its members, managers, officers, agents, instructors, employees, volunteers, and the other participants in or members of the applicable Classes from any and all liability, injury, claims, demands, damages, expenses, costs, actions or causes of actions known or unknown, past, present or future for personal injuries (including bodily injury, permanent disability or death) and/or damages which are alleged to have arisen out of, resulted from or be related to the participation by the Youth in any activity involved in any of the Classes, including, without limitation, any exercises that may be undertaken in or during any of the Classes.

I/WE HAVE FULLY READ THIS RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND MEANING, THE LEGAL IMPACT THEREOF, AND THAT I/WE HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I/WE HAVE HAD THE OPPORTUNITY OT HAVE MY/OUR ATTORNEY REVIEW THIS DOCUMENT AND EXPLAIN IT TO ME/US PRIOR TO SIGNING MY/OUR NAME(S) BELOW. I/WE VOLUNTARILY, OF MY/OUR OWN FREE WILL AND WITHOUT DISTRESS OR COERCION SIGN THIS RELEASEE AND WAIVER OF LIABILITY AND INDEMNIFICATION AGREEMENT.
